Dear Members of Congress:

We, the 151 undersigned national, state, and local organizations, ask you to pledge to protect the civil rights of District of Columbia residents, and the ability of D.C. to self-govern, by rejecting federal legislation that undermines its democratic institutions or revokes laws duly approved by D.C. voters or representatives.

Any attack on the District of Columbia's democratic institutions and right to self-governance is an attack on American democracy itself. The escalation of federal overreach into D.C. affairs – including the deployment of federal law enforcement and the National Guard – is a direct challenge to self-determination and representative democracy during President Trump's tenure. These actions make D.C. a testing ground for authoritarian tactics, designed to erode local control and normalize federal intervention that can and will be deployed in states and cities across the country.

When Congress allows D.C.'s autonomy to be undermined, it is not just D.C.'s values, families, union members, and locally-approved policies under attack. It is also an attack on American democracy and the fundamental principle of self-governance. D.C. is home to nearly 700,000 residents, more than the states of Wyoming and Vermont. D.C. is not just a jurisdiction filled with bureaucrats; D.C. is rich with culture and vibrant communities, including a population that is 44 percent Black. D.C. remains uniquely vulnerable to Congressional and federal overreach. In these precarious times, we call on you to commit to voting against any legislation that overturns local laws or weakens D.C.'s ability to govern itself.

Examples of recent attacks on Washington, D.C.'s right to self-governance include:

- President Trump's takeover of the Metropolitan Police Department and the influx of federal law enforcement racially profiling, harassing, arresting, detaining, and even transporting residents to facilities far from D.C.;<sup>2</sup>
- Congressional approval of a law forcing D.C. to cut its local budget by over \$1 billion;<sup>3</sup> and,
- Introduction of bills in the U.S. Senate and House to repeal the Home Rule Act.<sup>4</sup>
- Consideration of federal legislation intended to undermine D.C.'s autonomy on issues such as sentencing, reentry, cash bail, pre-trial policies, and policing reform, a school voucher program, the criminalization of camping and therein homelessness, the nomination of D.C. judges and election of the D.C. Attorney General, among other concerning proposals.

We call on you to commit to the following: Out of respect for the autonomy of the District of Columbia, and in defense of American democracy, pledge to vote against any bill that undermines the democratic institutions of the District of Columbia or revokes its laws.
