IN THE U.S. SUPREME COURT

Shell v. Mississippi, 498 U.S. \_\_\_\_, 112 L.Ed.2d 1, 111 S.Ct. \_\_\_\_ (October 29, 1990) (per curiam). Trial court's limiting instruction to define the "especially heinous, atrocious or cruel" aggravating factor is not constitutionally adequate under Godfrey v. Georgia, 446 U.S. 420 (1980) and Maynard v. Cartwright, 486 U.S. 356 (1988). To the extent that the Mississippi Supreme Court relied on this aggravating factor, the sentence was reversed. See Clemons v. Mississippi, 494 U.S. \_\_\_\_ (1990).

Perry v. Louisiana, 498 U.S. \_\_\_\_, 112 L.Ed.2d 338, 108 S.Ct. \_\_\_\_ (November 13, 1990) (per curiam). Judgment vacated and remanded for further consideration in light of Washington v. Harper, 494 U.S. \_\_\_\_ (1990).

Cage v. Louisiana, 498 U.S. \_\_\_\_, 112 L.Ed.2d 339, 111 S.Ct. \_\_\_\_ (November 13, 1990) (per curiam). Definition of reasonable doubt by state trial judge as "such doubt as would give rise to a grave uncertainty" and "an actual substantial doubt," combined with requirement that guilt be established to a "moral certainty" violates defendant's rights under the Due Process Clause.

Minnick v. Mississippi, 498 U.S. \_\_\_\_, 112 L.Ed.2d 489, 111 S.Ct. \_\_\_\_ (December 3, 1990). Once counsel is requested, police interrogation must cease, and the rule of Edwards v. Arizona, 451 U.S. 477 (1981) prohibits any reinitiation of interrogation without presence of counsel, irrespective of whether the accused has consulted with counsel.

In Re Berger, 498 U.S. \_\_\_\_, 112 L.Ed.2d 710, 111 S.Ct. \_\_\_\_ (January 14, 1991) (per curiam). Appointed counsel representing capital defendant before U.S. Supreme Court is limited to \$5,000 in fees, even though 21 U.S.C. § 848(q)(10) prescribes no such limitation.

Ohio v. Huertas, 498 U.S. \_\_\_\_, 112 L.Ed.2d 837, 111 S.Ct. \_\_\_\_ (January 22, 1991) (per curiam). Writ of certiorari dismissed as improvidently granted.

Parker v. Dugger, 498 U.S. \_\_\_\_, 112 L.Ed.2d 812, 111 S.Ct. \_\_\_\_ (January 22, 1991). While a reviewing court in a weighing state may, after striking aggravating factors, reweigh the evidence, see Clemons v. Mississippi, 494 U.S. \_\_\_\_, the Florida Supreme Court failed to conduct an independent reweighing of the evidence. It erroneously relied on what it took to be the trial court's finding of no mitigating circumstances, even though the record supported a showing of nonstatutory mitigating evidence.

Burden v. Zant, 498 U.S. \_\_\_\_, 112 L.Ed.2d 962, 111 S.Ct. \_\_\_\_ (February 19, 1991) (per curiam). Court of Appeals, in habeas corpus action, held to have improperly failed to give statutory presumption of correctness to state court finding that prosecution witness testified under grant of immunity. Reversed and remanded for reconsideration of petitioner's conflict-of-interest claim.

Ford v. Georgia, 498 U.S. \_\_\_\_, 112 L.Ed.2d 935, 111 S.Ct. \_\_\_\_ (February 19, 1991) (unanimous). Georgia's contemporaneous objection rule held not adequate and independent state ground to bar federal review of claim under Batson v. Kentucky regarding trial which preceded announcement of the rule. Although defense pretrial motion made no mention of a denial of equal protection, its allegation of a prosecutorial pattern of excluding African Americans from the jury held sufficient to set forth a claim under the pre-Batson evidentiary theory articulated in Swain v. Alabama.

Arizona v. Fulminante, 59 U.S.L.W. 4235 (U.S. March 26, 1991). Petitioner's confession to fellow inmate, a government agent, as result of promise by fellow inmate to protect petitioner from other inmates, was coerced and thus inadmissible; erroneous admission of coerced confession may be harmless error; admission not harmless under the circumstances of the case.

Powers v. Ohio, 59 U.S.L.W. 4268 (U.S. April 1, 1991) (non-capital). White criminal defendant held to have standing to bring equal protection challenge against prosecution's use of its peremptory strikes to remove African-Americans from jury venire. Establishing a prima facie case under Batson no longer requires that criminal defendant and struck jury venire member be from the same race.

McCleskey v. Zant, 59 U.S.L.W. 4288 (U.S. April 16, 1991). State prisoner pursuing successive habeas corpus petition may commit abuse of the writ not only through deliberate abandonment of a claim in the original petition, but also

through inexcusable neglect. That standard held to be the same as the "cause and prejudice standard" governing state procedural default. Held that failure to raise Massiah violation claim in first habeas petition constitutes abuse of the writ, even though prosecution had denied any misconduct.

#### Capital Cases Pending in the 1990 Term

Yates v. Evatt, No. 89-7691, 59 USLW 3243, cert. granted (October 1, 1990). Whether South Carolina's application of harmless error analysis to a Sandstrom v. Montana, 442 U.S. 510 (1979) violation conflicts with the requirements of Rose v. Clark and Carella v. California. (Argued)

Mu'Min v. Virginia, No. 90-5193, cert. granted, 59 USLW 3302 (October 9, 1990). Whether defendant's rights under the Sixth, Eighth and Fourteenth amendments were violated by trial court's refusal to allow the defense to question prospective jurors as to what they had read or heard about the crime. Case below Mu'Min v. Commonwealth, 389 S.E.2d 886 (Va. 1990).

Schad v. Arizona, No. 90-5551, cert. granted, 59 USLW 3302 (October 9, 1990). Whether a capital conviction obtained without a majority or a unanimous vote by a jury violates defendant's Sixth and Fourteenth Amendment rights; whether under Beck v. Alabama, 447 U.S. 625 (1980) a necessary included offense is a "lesser included offense" under state law. Case below Schad v. Arizona, 788 P.2d 1162 (Ariz. 1989).

Lankford v. Idaho, No. 88-7247,  
cert. granted, 59 USLW 3293  
(October 15, 1990. Whether the  
trial judge's imposition of the  
death sentence after prosecutor's  
notification that he would not seek  
the death penalty violated  
petitioner's Sixth, Eighth, and  
Fourteenth Amendment rights. Case  
below State v. Lankford, 747 P.2d  
710 (Idaho 1987).

Coleman v. Thompson, No. 89-7662,  
cert. granted, 59 USLW 3325  
(October 29, 1990). Whether Harris  
v. Reed, 489 U.S. 255 (1989) allows  
a federal court in federal habeas  
corpus review, proceeding on state  
law and state court record to  
determine whether federal claims  
are barred by state procedural  
default; whether federal court  
should waive procedural default  
resulting from postconviction  
counsel's failure to file timely  
appeal (brief was one day late)  
when default would bar any hearing  
on petitioner's constitutional  
claims; whether the deliberate  
bypass standard of Fay v. Noia, 372  
U.S. 391 (1963), applies to  
procedural default resulting from  
failure to file a timely appeal.  
Case below Coleman v. Thompson, 895  
F.2d 139 (4th Cir. 1990).

Payne v. Tennessee, No. 90-5721, 59  
U.S.L.W. 3590 (U.S. February 26,  
1991). Questions presented: (1)  
Did the introduction of victim-  
impact evidence, when combined with  
statements and conduct of  
prosecutor, deny capital  
defendant's rights under Eighth and  
Fourteenth Amendment's? (2)  
Should Booth v. Maryland and South  
Carolina v. Gathers be overruled?  
(Argued April 24, 1991).

Dawson v. Delaware, No. 90-6704,  
cert. granted 59 U.S.L.W. 3672  
(April 1, 1991). Question  
presented: May Delaware use  
petitioner's constitutionally  
protected racist association or  
belief as an aggravating  
circumstance in a capital  
sentencing hearing in order to  
support a sentence of death for  
murder when there is no evidence  
that the murder was motivated by  
this association or belief?
