IN THE U.S. SUPREME COURT

Capital Cases

Dawson v. Delaware, No. 90-6704, cert. granted, 59 U.S.L.W. 3672 (April 2, 1991). Question presented: May Delaware use petitioner's constitutionally protected racist association or belief as an aggravating circumstance in a capital sentencing hearing in order to support a sentence of death for murder when there is no evidence that the murder was motivated by this association or belief?

Stringer v. Mississippi, No. 90-6616, cert. granted, 59 U.S.L.W. 3769 (May 14, 1991). Question presented: Were Clemons v. Mississippi, 110 S.Ct. 1441 (1990) and Maynard v. Cartwright, 486 U.S. 356 (1988), dictated by precedent, such that they cannot be considered "new rules" under Teague v. Lane, 489 U.S. 288 (1989)?

Riggins v. Nevada, No. 90-8466, cert. granted, 60 U.S.L.W. 3257 (October 8, 1991). Question presented: Whether forced medication during trial violates a defendant's constitutional right to a full and fair trial.

Morgan v. Illinois, No. 91-5118, cert. granted, 60 U.S.L.W. 3292 (October 15, 1991). Question presented: Can a state prohibit inquiry to reveal whether a potential juror will automatically impose death if the defendant is convicted of murder?

Medina v. California, No. 90-8370, cert. granted, 60 U.S.L.W. 3309 (October 22, 1991). Question presented: After a doubt has been declared by a trial court as to the competency of a criminal defendant to be tried, can a state, consistent with due process of law, place the burden of proving incompetency upon the defendant whose competency is in issue, and impose a presumption that the defendant is competent, at the same time as it denies the defendant the right to invoke or waive constitutional rights in the proceeding to determine competency, on the ground that the defendant is incompetent to exercise them?

Sochor v. Florida, No. 91-5843, cert. granted, 60 U.S.L.W. 3374 (November 19, 1991). Questions presented: (1) Did the Florida Supreme Court's review of petitioner's death sentence violate the Eighth and Fourteenth Amendments where that court upheld the sentence even though the trial court had instructed the jury on, and had applied, an improper aggravating circumstance, where the Florida Supreme Court did not reweigh the evidence or conduct a harmless error analysis as to the effect of improper use of the circumstance on the jury's penalty verdict? (2) Did the application of Florida's "especially heinous, atrocious or cruel" aggravating circumstance at bar violate the Eighth and Fourteenth Amendments?

Sawyer v. Whitley, No. 91-6382, cert. granted, 60 U.S.L.W. 3374 (November 19, 1991). Question presented: What is the appropriate standard to be applied when determining whether the "fundamental miscarriage of justice" exception, Smith v. Murray, 477 U.S. 527 (1986), will allow for consideration of claims presented in a successor habeas corpus petition?

Non-Capital Cases

Kenney v. Tamayo-Reyes, No. 90-1859, cert. granted, 60 U.S.L.W. 3218 (October 8, 1991). Question presented: Is "deliberate by-pass" or "cause and prejudice" the correct test for determining when a federal habeas petitioner will be excused for failing to develop a material fact in state proceedings?

Georgia v. McCollum, No. 91-372, cert. granted, 60 U.S.L.W. 3333 (November 5, 1991). Question presented: Whether the rule of Batson v. Kentucky, 476 U.S. 79 (1986) applies to criminal defendants.

Wright v. West, No. 91-542, cert. granted December 18, 1991. Parties asked to brief and argue the following additional question: In determining whether to grant a petition for a writ of habeas corpus by a person in custody pursuant to the judgment of a state court, should a federal court give deference to the state court's application of law to the specific facts of the petitioner's case or should it review the state court's determination de novo?

Previously, we represented only the racial combination for each case. Total victim figures will, from now on, be listed not only by race but by sex. We will also indicate the number of multiple victims, if any, next to the name of the defendant.

IN THE U.S. SUPREME COURT

CASES DECIDED

OCTOBER 1991 TERM

Stringer v. Black, No. 90-6616, 60 U.S.L.W. 4214 (March 10, 1992).

Maynard v. Cartwright, 486 U.S. 356 (1988), which condemned as unconstitutionally vague statutory aggravating circumstance that authorized imposition of death penalty if murder was "especially heinous, atrocious, or cruel," was dictated by precedent in Godfrey v. Georgia, 446 U.S. 420 (1980), and hence did not announce a "new rule" that would be unavailable as basis for federal habeas corpus relief in cases in which conviction and sentence had already become final; any differences between capital punishment scheme of "weighing," "non-weighing" types does not make principle of Godfrey, which arose against background of non-weighing scheme, a new rule when applied in context of weighing scheme.

Dawson v. Delaware, No. 90-6704, 60 U.S.L.W. 4197 (March 10, 1992).

Admission at capital sentencing hearing of evidence of defendant's racist gang membership, which was neither tied to crime of conviction nor probative of anything other than defendant's abstract belief and therefore was not relevant to issue in sentencing hearing, violated First Amendment.

CASES PENDING OCTOBER 1991 TERM

Riggins v. Nevada, No. 90-8466, cert. granted, 60 U.S.L.W. 3257

(October 8, 1991). Question presented: Whether forced medication during trial violates a defendant's constitutional right to a full and fair trial.

Morgan v. Illinois, No. 91-5118, cert. granted, 60 U.S.L.W. 3292 (October 15, 1991). Question presented: Can a state prohibit inquiry to reveal whether a potential juror will automatically impose death if the defendant is convicted of murder?

Medina v. California, No. 90-8370, cert. granted, 60 U.S.L.W. 3309 (October 22, 1991). Question presented: After a doubt has been declared by a trial court as to the competency of a criminal defendant to be tried, can a state, consistent with due process of law, place the burden of proving incompetency upon the defendant whose competency is in issue, and impose a presumption that the defendant is competent, at the same time as it denies the defendant the right to invoke or waive constitutional rights in the proceeding to determine competency, on the ground that the defendant is incompetent to exercise them?

Sochor v. Florida, No. 91-5843, cert. granted, 60 U.S.L.W. 3374 (November 19, 1991). Questions presented: (1) Did the Florida Supreme Court's review of petitioner's death sentence violate the Eighth and Fourteenth Amendments where that court upheld the sentence even though the trial court had instructed the jury on, and had applied, an improper aggravating circumstance, where the Florida Supreme Court did not reweigh the evidence or conduct a harmless error analysis as to the effect of improper use of the circumstance on the jury's penalty verdict? (2) Did the application of Florida's "especially heinous,

atrocious or cruel" aggravating circumstance at bar violate the Eighth and Fourteenth Amendments?

Sawyer v. Whitley, No. 91-6382, cert. granted, 60 U.S.L.W. 3374 (November 19, 1991). Question presented: What is the appropriate standard to be applied when determining whether the "fundamental miscarriage of justice" exception, Smith v. Murray, 477 U.S. 527 (1986), will allow for consideration of claims presented in a successor habeas corpus petition?

NON-CAPITAL CASES

Kenney v. Tamayo-Reyes, No. 90-1859, cert. granted, 60 U.S.L.W. 3218 (October 8, 1991). Question presented: Is "deliberate by-pass" or "cause and prejudice" the correct test for determining when a federal habeas petitioner will be excused for failing to develop a material fact in state proceedings?

Georgia v. McCollum, No. 91-372, cert. granted, 60 U.S.L.W. 3333 (November 5, 1991). Question presented: Whether the rule of Batson v. Kentucky, 476 U.S. 79 (1986) applies to criminal defendants.

Wright v. West, No. 91-542, cert. granted December 18, 1991. Parties asked to brief and argue the following additional question: In determining whether to grant a petition for a writ of habeas corpus by a person in custody pursuant to the judgment of a state court, should a federal court give deference to the state court's application of law to the specific facts of the petitioner's case or should it review the state court's determination de novo?

CASES TO BE DECIDED IN 1992 TERMS

Herrera v. Collins, No. 91-7328, cert. granted, 60 U.S.L.W. 3577 (February 19, 1992). Questions presented: (1) Does it violate Eighth and Fourteenth Amendments to execute a person who has been convicted of murder but who is innocent? (2) If so, must state courts provide meaningful mechanism for hearing claims of actual innocence in death penalty cases? (3) What procedures are necessary in federal court for adjudicating claims of actual innocence in death penalty cases?

Richmond v. Lewis, No. 91-7094, cert. granted, 92 WL 12158, (March 30, 1992). Questions presented: (1) Whether petitioner's death sentence contravenes the Eighth and Fourteenth Amendments because it was upheld by the Arizona Supreme Court on the basis of an application of Arizona's "especially heinous, atrocious or cruel" aggravating circumstance which either extends the circumstance to a set of facts that no rational factfinder could conclude fall within it or arbitrarily assumes a set of facts that no actual factfinder has ever found in this case. (2) Whether a federal habeas corpus court may apply a rule of "automatic affirmance" to a death sentence which was based on both constitutional and unconstitutional aggravating circumstances, when the law of the state that imposed the sentence requires the sentencer to weigh these aggravating circumstances against the mitigating circumstance in determining the penalty.
